AN EXECUTIVE ORDER ORGANIZING THE MUNICIPAL ADVISORY COMMITTEE FOR THE PANTAWID PAMILYANG PILIPINO PROGRAM

WHEREAS, the Pantawid Pamilyang Pilipino Program is a government program which aims to help the poor by providing cash grants to the beneficiaries, and which aims to improve their health, nutrition and education;

WHEREAS, there is a need to organize the Municipal Advisory Committee to act as an advisory body in the implementation of the program;

WHEREFORE, by virtue of the powers vested in me by law, I, PASCUAL A. SACGACA, Municipal Mayor, direct the organization of the Municipal Advisory Committee as follows:

The functions of the committee are:

1. Oversee the overall implementation of the Pantawid Pamilya in the municipality.
2. Ensure that the education and health services required by the program are available and adequate.
3. Facilitate the accreditation of its Rural Health Units to PhilHealth
4. Ensure that the corresponding LGU counterpart for the enrolment of the household beneficiaries to PhilHealth is provided.
5. Provide logistics support to the Municipal and LGU links.
6. Ensure the establishment of an efficient recording system in all health and educational facilities.
7. Review progress reports on verification of commitments and supply of services and produce actions as needed to improve program operation.
8. Facilitate and address complaints and requests of concerned poor families.
9. Hold regular quarterly and special meetings to ensure timely resolution of implementation issues.
10. Furnish the PAC with a quarterly MAC accomplishment report including issues and concerns.

This Executive Order shall take effect immediately and shall be in full force until amended /revoked/ modified accordingly.
